

Council's transaction centre to manage public access to online Development Applications (DAs) is called eServices.

This fact sheet outlines the steps you need to take to access DAs that are being advertised in accordance with Part A14 of Development Control Plan 2014.



Find a Development Application

You can find DAs online and view DAs on exhibition.

From Council's homepage select 'Find a Development Application'

Select:

View plans for a DA currently being advertised

This search will list all DAs currently on being advertised.

From the landing page, you can either sort by **Received date** or the **Street name**.

You can also scroll through the list.

To view the relevant DA, select the address link on the application.

Once you have viewed the DA and associated plans, you can also lodge a submission directly with Council from this screen by selecting:

'Want to make a Submission?'

- View plans and reports for DAs currently on exhibition.
 - Lodge an online submission to a DA on exhibition.

Notes:

- 1. If amended plans are submitted and re-exhibited, they will be available here to view along with the original plans.
- The DA will be available to view in the 'Advertised Development Applications' page until the exhibition period is finished. Once the exhibition period is finished the plans will still be available to view in the DA Enquiry.
- 3. The proposed plans will remain online until such a time the DA is determined. They will then be replaced with a Determination Notice and approved plans (where relevant).

A word about other functions in the eServices Transaction Centre

The eServices portal is also used for other purposes, such as:

- Payments to make online payments for Debtors, Rates and Water / Sewer accounts.
- Public access sessions and submissions to lodge a request to speak at a Council meeting.
- **Report It** to get in touch with Council to report a problem or request a service.
