How to view Recently Determined Development Applications

Council's transaction centre to manage public access to online Development Applications (DAs) is called eServices.

This fact sheet outlines the steps you need to take view DAs and modifications that have recently been determined.



Find a Development Application

You can find DAs online and view DAs on exhibition.

From Council's homepage select 'Find a Development Application'

Select:

View what's been determined in the last 30 days

This feature allows you to view DAs that have been determined in the last 30 days.

From the landing page, you can either sort by Received date or the Street name. You can also scroll through the list.

To view the relevant DA, select the address link on the application.

Note: you can still access DAs determined outside this period by selecting 'Find a DA or track progress' from the original menu.

Documents are where the exhibition documentation relating to a DA is located. Select the linked document to view the Notice of determination, which will include certain conditions that need to be met or reasons for refusal. Where relevant, approved plans will also be available..

Notes:

- 1. The DA will be available to view in the 'Recently Determined Development Applications' page for 30 days past the date it was determined. Once the exhibition period is finished the documents will still be available to view by selecting 'Find a DA or track progress of an application' from the menu.
- 2. This is a relatively new process. Determination documentation notices are available from DAs determined after 1 January 2018. Contact Council's Local Approvals area for DAs outside this period.

A word about other functions in the eServices Transaction Centre

The eServices portal is also used for other purposes, such as:

- Payments to make online payments for Debtors, Rates and Water / Sewer accounts.
- Public access sessions and submissions to lodge a request to speak at a Council meeting.
- **Report It** to get in touch with Council to report a problem or request a service.
